Considering the Outcome of Prioritizing

How does the selected strategy or intervention build community capacity and power in communities most affected by inequities (community capacity focus areas include active participation, leadership, rich support networks, skills and resources, critical reflection, sense of community, understanding of history, articulation of values, and access to power)? 1

Do priorities conflict with priorities that communities facing inequities have prioritized?

Where do funding requirements or limitations fit into the prioritization process? 7

Who is going to be affected by the chosen priorities? How do different choices affect populations and groups differently? Who benefits? Who is burdened? 7

To what degree is community diversity and the contribution of diversity (cultural, race, ethnicity, linguistics) reflected in priority determination and selection? Are there ways to maximize equitable opportunities and impacts? What provisions could be changed or added to ensure positive impacts on racial equity and inclusion? 1

Are selected strategies responsive to community diversity (cultural, race, ethnicity, linguistic)? 3 What adverse impacts or unintended consequences could result from this program or policy?

Which racial/ethnic groups could be negatively affected? What other sub-populations could be negatively affected? How could adverse impacts be prevented or minimized? 3
